NOTICE: MOTOR VEHICLE DAMAGE APPRAISERS LICENSE RENEWAL

TO:

SUBJECT: Motor Vehicle Damage Appraisers Renewal Process

Date: September 13, 2017

Please be advised that it is time to renew your Motor Vehicle Damage Appraiser's license. Renewal begins on October 1, 2017 and closes on October 31, 2017. To complete the license renewal process, all licensed Motor Vehicle Damage Appraisers must complete an online renewal application and pay the \$80 renewal fee by October 31, 2017.

MOTOR VEHICLE DAMAGE APPRAISER'S LICENSE FEES

- The renewal license fee for **resident and nonresident motor vehicle damage appraisers is \$80.**

PENALTY PROVISION AND REINSTATEMENT PROCESS

South Carolina Code Section 38-49-30 provides that if the license fee is not received when due, the license must be canceled. If the appraiser's license is canceled for failure to renew, a renewal application and payment of a penalty fee double the regular fee must be paid before the license can be reinstated. Therefore, if an appraiser allows his/her license to cancel, the following penalty fee will be applicable:

- A **reinstatement fee** of \$80 will be due in addition to the \$80 renewal fee for a total of \$160.

CHANGE OF ADDRESS

South Carolina Code Section 38-49-25 requires Motor Vehicle Damage Appraisers to notify the Department within 30 days of any change in address. Many appraisers have not complied with this law in the past and have paid administrative penalties as a result. To avoid having to pay penalty fees, the South Carolina Department of Insurance has made arrangements where individuals can go online and update their address information. That website address is www.doi.sc.gov. Once there, select "**ONLINE SERVICES**" then select "**UPDATE INDIVIDUAL DEMOGRAPHICS**" and follow the instructions.

Motor vehicle damage appraiser's licenses are continuous, if not cancelled or revoked. A renewal license can be printed from our website showing the new renewal date. To obtain a copy of new license please follow the **PRINTING LICENSES** instructions that can be found on the Appraiser Section of the website.

MOTOR VEHICLE DAMAGE APPRAISER RENEWAL INSTRUCTIONS ARE AS FOLLOWS:

RENEWAL OPTION 1:

1. Go to the department's home page (www.doi.sc.gov).
2. On the home page, click on "Online Services."
3. Under the General Public heading click on "Renew/Reinstate Individual License."
4. Scroll to the bottom of the Terms and Instructions page and click on "I Agree."
5. Enter your SC license number, the last 4 digits of your social security number and your date of birth.
6. Choose the License you are renewing.
7. Follow the instructions on the screen.
8. Select payment option.
9. Once the renewal is completed, a confirmation page will be displayed. Please print and keep this page as your receipt.

Fees may be paid by electronic check, or by credit card. If paid by credit card, a \$1.43 processing fee and a \$1.00 portal fee will be added to the \$80 license renewal fee.

RENEWAL OPTION 2:

1. Go ONLINE to renew at: www.nipr.com.
2. Follow NIPR's online instructions.
3. Individuals renewing through NIPR must pay a \$5 renewal transaction fee in addition to the license fee.
4. Once the online renewal is completed, NIPR will send an email confirming that the renewal has been accepted. Please keep NIPR's email as your receipt. Do not send verification to the Department.

TO CHECK THE STATUS OF YOUR RENEWAL, DO THE FOLLOWING:

1. Go to the Department's home page (www.doi.sc.gov)
2. On the right side of the screen, click on the "**ONLINE SERVICES**" button.
3. Click Search for individuals.
4. Key in your license number OR your last and first name.
5. When the next screen displays, click on the individual's name.
6. Scroll down to license type and click. Your renewal status will be reflected on the next page.
