- Defendant has not complied with the conditions specified in the order regarding electronic monitoring and home detention (see attached Affidavit form and the Rules/Conditions governing Home Detention).
- The Defendant (please check all that apply and attach the necessary documentation):
  - Violated curfew or jurisdictional conditions of the order (i.e., did not comply with conditions limiting time away from his residence to church, doctor's appointments, school, other approved appointments, or work hours as set forth in the order).
  - Tampered with or attempted removal of the electronic monitoring device.
  - Failed to maintain equipment such as telephone or cell phone.
  - Failed to pay the full monthly fees required for the supervision or monitoring and monitoring device.

- Engaged in alcohol or drug use in violation of the pre-trial release order and conditions.

- Left the State of South Carolina.
